About the Accounting Olympiad:

The Accounting Olympiad is a unique initiative of School of Commerce, Finance and Accountancy, CHRIST (Deemed to be University), Delhi NCR Campus. Aim of organizing this Olympiad is to unearth hidden accounting talents and ignite a deep appreciation for the subject among young minds. This Olympiad offers a national stage for talented students to compete, promoting excellence in accounting as an academic field.

The School of Commerce, Finance and Accountancy has conducted its first ever Accounting Olympiad in the year 2023 with a remarkable participation of 11th and 12th standard students. We have received participants from 10 States of India.

Due to the overwhelming response from the 11th and 12th standards students in the year 2023, this year the School has added a new category wherein the undergraduate students can also participate in the Accounting Olympiad.

ArivuPro Academy, Bangalore is our Knowledge Partner for the Accounting Olympiad 2024.

Eligibility: Students who are studying in 11th or 12th or B.Com (or equivalent course) can participate in this Olympiad.

Category: There are three categories of this exam

- Category I : 11th Standard Students
- Category II : 12th Standard Students
- Category III : Undergraduate Students

Levels of Exam: There are two levels of the Olympiad

- Preliminary Round: It will be conducted in virtual mode.
- Final Round: It will be held at CHRIST (Deemed to be University), Delhi NCR Campus.

Date of Exam:

- Preliminary Round: 21 January, 2024
- Final Round: 04 February, 2024



Questions Pattern:

- Preliminary Exam : MCQ
- Final Exam : MCQ and Problem Solving

Type of Questions, Marking scheme and Duration of exam:

- Preliminary Exam : 20 Multiple Choice Questions will be asked. Each question will carry 1 mark. The duration of the exam will be for 30 minutes. This is a qualifying level exam. After qualifying this level, participants will be eligible to appear for Final Exam.
- Final Exam: Pattern of final round exam will be as follows:
 - Maximum Marks - 80
 - 24 Multiple Choice Questions (each question will carry 2.5 marks)
 - 02 Problem Solving Questions (each question will carry 20 marks)
 - Duration of Exam: 2 Hours

Prizes (for each category):

- First Prize : Gold Medal, Rank Certificate and Cash Award Rs. 8,000
- Second Prize : Silver Medal, Rank Certificate and Cash Award Rs. 6,000
- Third Prize : Bronze Medal, Rank Certificate and Cash Award Rs. 5,000
- Five Recognition Prizes : Rank Certificate and Gift Hampers
- Participation certificate to all the participants.
- Best Accounting School and College Award : Trophy and Certificate*

* This award will be given to the school and college, whose maximum number of students will score above 75% marks in final round of the exam.

Registration and Fee Payment:

The registration fee is Rs.200 per participant for each category. Participants can pay the registration fee through scanning following bar code. Kindly select main head “Fest and Conference” and then sub head “Accounting Olympiad” to pay the fee. After fee payment collect the receipt and scan the another bar code to register.

Syllabus for Preliminary and Final Round Exams:

Category I

Introduction of Accounting, Accounting Concepts and Conventions, Introduction of Accounting Standards, Journal, Subsidiary Books, Ledger, Trial Balance, Rectification of errors, Bank Reconciliation Statement, Depreciation, Provisions and Reserves, Financial Statement of Sole Proprietorship

Category II

Accounting for Partnership Firms - Change in Profit Sharing Ratio, Admission, Retirement and Death of a Partner and Dissolution of a Partnership Firm.
Accounting for Companies- Issue of Shares, Forfeiture and Reissue of Forfeited Shares, Issue of Debentures, and Financial Statement of Companies.
Analysis of Financial Statement - Comparative Statement, Common Size Statement, Trend Analysis and Ratio Analysis.
Cash Flow Statement

Category III
