 - 1.) The committee felt the importance of a joint meeting of the Time-Table Committee (Arts & Commerce) and Time-Table Committee (Sciences). In the light of the same, it was decided that a joint meeting of the committees should be held at the beginning of each semester to observe the time-table and make changes as required. No change should be made without arriving at a decision in the joint meeting.

Cooperating with the decision already having been taken by the Time-Table Committee (Sciences), the changes in the time-slots of Generic Elective courses (GEs) for the Ist and IIIrd semesters were considered by the Time-Table Committee (Arts & Commerce). The lecture for GE (Ist semester) earlier placed at 12.30 pm on Tuesday was shifted to 1.30 pm on the same day, and the lecture for GE (IIIrd semester) earlier placed at 1.30 pm on Tuesday was shifted to 12.30 pm on the same day as confirmed by Dr. G.S. Chilana. This change, however, applies only to the forthcoming semester (July – November 2018). This decision may be reversed from the next semester onwards (January – April 2018) restoring the earlier arrangements for the GE courses in the Time-Table.

- 2.) The committee decided to retain the scheme devised (Grid pattern) for the allocation of time-slots for the Discipline courses and Languages for B.A Programme in the Central Time-Table. However, keeping in mind the strength of the classes the earlier arrangements with regard to the allocation of rooms should be retained,
- 3.) A new room should be available to meet the classes on time-table which have not been allocated any room. In this regard, it was noted that these classes were placed in Room no. 10 in the Time-Table for 2017-18 but later this room was engaged by the college for other use. The Principal should be requested to allot a new room in place of Room no. 10 at the earliest in order to mark the same in time-table.
- 4.) The new rooms (Department Rooms, Lecture Rooms, and Tutorial/Preceptorial Rooms) allotted to different departments during the Academic Year 2017-18 should be occupied and used by respective departments vacating the earlier used rooms in case those have been allotted to different departments.
