NOTICE

As per request of 1st year and 2nd year old residents Boys and Girls (2023-24), regarding temporary stay in the Hostel due to Non-declaration of University Examination results and subsequent decision of the Hostel Committee meeting held on 05.06.2024, at 12:15 pm in Hostel Office, old 1st year and 2nd year residents of 2023-24, are required to submit their application for temporary stay to the Hostel Office on Hostel mail or by hardcopy in the Hostel Office latest by 07.08.2024 upto 5:00 pm. Their temporary stay is subject to assessment report of the structural stability of Hostel and have to vacate the Hostel immediately if directed in the assessment of the report.

They are also required to submit an undertaking for vacating Hostel Room within 7 days if their name do not appear in admission merit list (2024-25).

For the temporary stay, students are required to pay Mess Advance Rs. 20,000.00 (for Girls Residents) and Rs. 22,500.00 (for Boys Residents), along with old dues if, any. This amount will be adjusted in the admission fee (2024-25) or will be refunded after deduction of hostel dues during their period of stay, if they don't get admission in 2024-25 merit list of the Hostel.
